Temporary Letters Issued 06/05/18. Argued by Counsel and submitted. Court finds good cause under UCCJEA as an emergency for a temporary. Ex parte orders granted. The Court finds good cause to grant Temporary Guardianship to Evelyn Valenzuela. Ex parte order signed by the Court.

Continued from 07/03/18. All temporary orders/letters to remain in full force and effect.

At Ex Parte Hearing held on 08/31/18, the court will grant the application for relief in part. The temporary guardianship will continue until 09/05/18 11am. If an emergency arises the temporary guardian to contact the father. The court will terminate the temporary guardianship on 09/05/18 11am as the state of Texas is the home state per UCCJEA.
