THIS CASE IS SET FOR HEARING ON Request for findings re: Special Immigrant Juvenile Status by Milton Martinez Gutierrez (minor is 17).

THE FOLLOWING ISSUES AND/OR DEFICIENCIES IN THE PAPERS ARE NOTED

1. Petitioner, Milton Martinez Gutierrez a minor (17), requests that the court issue an order finding that minor is eligible for special immigrant juvenile status under the Special Immigrant Juvenile Status Statute (SIJS), 8 U.S.C., § 1101(a)(27)(J), which provides in relevant part as follows:
 - a. "The term 'special immigrant' means ... an immigrant who is present in the U.S. –
 - i. who has been declared dependent on a juvenile court located in the United States or whom such a court has legally committed to, or placed under the custody of, an agency or department of a State, or an individual or entity appointed by a State or juvenile court located in the United States, and whose reunification with 1 or both of the immigrant's parents is not viable due to abuse, neglect, abandonment, or a similar basis found under State law;
 - ii. for whom it has been determined in administrative or judicial proceedings that it would not be in the alien's best interest to be returned to the alien's or parent's previous country of nationality or country of last habitual residence; and
 - iii. in whose case the Secretary of Homeland Security consents to the grant of special immigrant juvenile status..."

2. The specific findings required under the statutory scheme would be: (1) that petitioner is an immigrant placed under the custody of an individual appointed by a state court (probate guardianship); (2) that petitioner's reunification with one or both parents is not viable due to abandonment; and (3) it is not in the petitioner's best interest to be returned to his/her home country.
3. Once the above findings are made, petitioner may then begin the process with the Bureau of Citizenship and Immigration Services to obtain legal permanent residence status. In other words, the findings requested are a prerequisite to filing a petition for a "green card."
4. State Superior Courts have jurisdiction to make factual findings of eligibility under SIJS See *N.O. v. Super. Ct. of Calif.*, County of Alameda, No. A122430 at 2-3 (Cal. Ct. App. 9/25/08). Thus, under the federal legislation, any superior court judge would have jurisdiction to hear the SIJS petition.
5. Petitioner, Martin Martinez Gutierrez (17) offers a declaration in support of the requested findings stating, inter alia, the following:
 - a. Milton was born on 11/28/200 in Mexico and lived there with minor's parents until 2005, when his mother left him to live with his father and brother. His father died in 2008 and he went to live with his mother until he came to the United States in 2016.
 - b. Milton was abused and neglected by minor's parents (see documents for specifics).
 - c. Milton was forced to move to the United States as he was abandoned by his mother while here on a visit.
 - d. Milton does not believe he can return to minor's mother as his mother does not want to take responsibility for him. Mother arrived in the United States in 2016 approximately 2 months after Milton arrived. After a couple of weeks mother left abruptly in the middle of the night without telling Milton, and returned to Mexico. Milton has had minimal contact with her since she returned to Mexico, and any communication they did have was initiated by Milton. Mother made no efforts to care for Milton when he did live with her. Milton alleges he was neglected and abandoned by his mother (see documents for specifics).
6. Per the statutory scheme, this petition is to proceed only if guardianship of the minor is granted pursuant to the accompanying petition.
7. **Need** notice of hearing as to Blanca Angelica Gutierrez, mother.

RECOMMENDATION

Need to clear note 7. Court to reach only if accompanying guardianship petition is first granted. Court's discretion re: factual findings that would support this petition.

 - ii. for whom it has been determined in administrative or judicial proceedings that it would not be in the alien's best interest to be returned to the alien's or parent's previous country of nationality or country of last habitual residence; and

- iii. in whose case the Secretary of Homeland Security consents to the grant of special immigrant juvenile status...”
2. The specific findings required under the statutory scheme would be: (1) that petitioner is an immigrant placed under the custody of an individual appointed by a state court (probate guardianship); (2) that petitioner’s reunification with one or both parents is not viable due to abandonment; and (3) it is not in the petitioner’s best interest to be returned to his/her home country.
3. Once the above findings are made, petitioner may then begin the process with the Bureau of Citizenship and Immigration Services to obtain legal permanent residence status. In other words, the findings requested are a prerequisite to filing a petition for a “green card.”
4. State Superior Courts have jurisdiction to make factual findings of eligibility under SIJS See *N.O. v. Super. Ct. of Calif.*, County of Alameda, No. A122430 at 2-3 (Cal. Ct. App. 9/25/08). Thus, under the federal legislation, any superior court judge would have jurisdiction to hear the SIJS petition.
