OFFICIAL 2019 CONTEST RULES

Qualified Participants:

The Law Day Contest is open to students attending a public or private school, or being home schooled, within the San Bernardino County and in **grades 9-12** or the equivalent.

Photograph Theme:

Capture an image that showcases the theme: "Free Speech, Free Press, Free Society", and include a short explanation of how the subject of your photo fits into the free society framework.

Ex. This picture captures the San Bernardino Justice Center. The Justice Center is a courthouse of the San Bernardino Superior Court, which belongs to the judicial branch of government. The judicial branch is responsible for interpreting the law and protecting citizens' rights, including the right to free speech and free press.

Steps to Enter:

- 1. Read and agree to the contest rules.
- 2. Take a photograph and include a short explanation.
- 3. Mail the photograph to the San Bernardino Superior Court or email the entry according to the instructions below

Contest Deadline:

Contest entries will be accepted beginning **February 18, 2019**. To be eligible for prizes, all entries must be submitted or postmarked by **April 15, 2019**.

Contest Prizes:

Prizes will be awarded for each division as follows:

 $\mathbf{1}^{\text{st}}$ Place and Overall Winner: Inscribed plaque presented to student by a Judge from the San Bernardino Superior Court

2nd Place: Inscribed plaque

3rd to 5th Place: Honorable Mention

Selection of winners and runners-up will be based on originality, creativity, adherence to the theme, and overall quality. With the permission of the winning students, their photographs may be reproduced in local papers and may be used to promote Law Day 2020!

Photograph Specifications:

Photographs must be at least 5 x 7 inches and smaller than 8 x 10 inches. Photographs outside of this size range are not eligible for the contest.

Color as well as black and white photographs are eligible.

Photographs may not incorporate any copyrighted characters (i.e. comics and/or television characters), photographs, and magazine or newspaper illustrations.

Photograph must be original, correct in safety concepts, and the exclusive work of the student entering the contest in idea, design, and execution. All photography should be positive in approach.

Submissions will not be accepted or eligible if they include- in the sole judgment of the committee- any content that contains or appears to contain:

- 1. Profane, obscene, or inappropriate material
- 2. Inappropriate language
- 3. Any derogatory characterization of any person or group based on age, race, color, gender, gender identity, citizenship, creed, national origin, physical appearance, political affiliation, union membership, or other unethical or lawful factors
- 4. Any actual or apparent copying or other infringement of another's intellectual property rights

All expenses involved in preparing and submitting an entry are the entrant's responsibility.

All submissions must include the information form at the bottom of this page in their submission. Necessary information includes the student's name, grade, age, teacher's name, school name, and school address. Please print clearly.

Contest Infrastructure:

The San Bernardino Superior Court Photograph Contest is sponsored by the San Bernardino Superior Court. The San Bernardino Superior Court Law Day Committee will select one winner and four runners-up from among the eligible entries that, in the sole discretion of the committee, meet the minimum quality standards and best reflect the theme. Winners will be announced on or about **May 1, 2019**.

All photographs and related intellectual property rights become the property of the San Bernardino Superior Court upon receipt and are not returned to the artist, his/her parents/legal guardians, instructor/teacher, school, state, or any other person(s) claiming a right, title, or other interest in the photograph. Photographs that have been used for any promotional purposes may not be submitted.
